#### **NEW BUSINESS**

### A. <u>PRESENTATION: JEAN SWESEY (RECREATION CENTER MEMBERSHIP FEE POLICY – DIFFERENTIAL RATES</u>

Jean Swesey spoke to the commission regarding the recreation center's membership fee policy. Her points included removing the rate difference between Cottonwood residents and non-residents, increasing promotions, and catering to families.

Mr. Faust and the commission discussed some of these items with Ms. Swesey and others present and why the fee structure is how it is.

### B. <u>PRESENTATION: TERRI CLEMENTS (RECREATION CENTER MEMBERSHIP FEE POLICY</u> – DIFFERENTIAL RATES

Terri Clements spoke to the commission regarding the recreation center's membership fee policy. She feels that Cottonwood residents have more of a buy in to the center and hence they should continue receiving rates lower than non-residents. She also believes the center would benefit from raising fees.

Mr. Faust and the commission discussed these items with Ms. Clements further.

### C. NORRIS DESIGN TEAM: RIVERFRONT TRAILHEAD AND DESIGN PROJECT – UPCOMING MEETINGS AND INFORMATION

Mr. Faust stated that the Norris design team met with staff August 14 to discuss the Riverfront trailhead project. They have a tentative stakeholders meeting scheduled for September 18. He reviewed some of the planned project details with the commission.

### D. BICYCLE PLAN UPDATE REVIEW AND REQUESTED APPROVAL

Mr. Faust briefly reviewed the draft version of the 2018 updated bicycle plan. It includes Cottonwood's plans to implement strategies to reach Silver status through the national organization.

Dr. Richards stated that the Bicycle Advisory Committee was requesting approval of the draft from the commission. He stated that the update is a more complete document than the previous one and gives staff more direction.

After discussion, Commissioner Croslin motioned that they approve the document. Commissioner Shaw seconded. Motion passed unanimously.
