The undersigned (Permittee) hereby requests space at the Cottonwood Municipal Airport in order to park or hangar the aircraft described above, and in consideration of the request being granted, agrees to the following:

1. Permittee shall abide by the airport operations and procedures manual.
2. Permittee agrees to pay rent quarterly in the amount of one hundred and eight dollars and 15 cents (\$108.15) for an open tie-down space or two hundred and sixty-two dollars and 65 cents (\$262.65) for a shaded tie-down space.
3. Permittee agrees to pay rent on time in quarterly installments prior to the first (1st) day of each new quarter at 816 N Main in Cottonwood, AZ 86326. Permittee understands that they will pay a late fee if they do not pay on time. The rent will become delinquent on the tenth (10th) day of the first (1st) month of each quarter, upon which a twenty percent (20%) late fee will be applied.
4. If a Permittee becomes 6 months in arrears on their fees, the City will place a lien on the aircraft (including the right to impound the aircraft at the permittee's expense) for the payment of all past due rent, late charges, interest, costs, and attorney fees. If the City takes this action, the permittee will only be able to continue parking their plane at the airport in the future upon advance payment equal to a year's worth of rent.
5. Permittee agrees to use the tie-down space exclusively for the securing of the aircraft described herein.
6. Permittee agrees to occupy the designated tie-down space with the above-named aircraft, unless otherwise arranged in advance. A change of aircraft assignment in assigned space will require an amendment to this permit.
7. Permittee agrees to keep the immediate area in good order and to advise the Airport Management of any needed maintenance or repairs.
8. Use of the space is for the Permittee only and is not transferrable. The Permittee shall not sublease said tie-down space.
9. Permittee shall not make any alterations to the tie-down space.
10. A thirty (30) day notice will be issued by first class U.S. Mail for any breach alleged under this permit. If by the end of the thirty (30) days, a remedy is not provided by Permittee, the Airport Manager may terminate this permit.
11. Permittee agrees to terminate this permit by notifying the Airport Manager in writing thirty (30) days in advance of vacating the tie-down space.
12. The Permittee shall indemnify and save harmless the City, its employees, officers and agents, from and against all losses, claims, demands, payments, actions, recoveries, and judgments of every nature and description brought against it, including attorney's fees and costs, by reason of any act, omission, negligence or claimed negligence of said Permittee, his agents or employees, arising from this permit.
13. Permittee shall be the registered owner of the aircraft stored per the Federal Aircraft Registration.
