1. **ZO 11-011** Consideration of a possible amendment to the Cottonwood Zoning Ordinance, Section 406 (Parking Code) reducing or eliminating certain parking requirements for properties located within the Cottonwood Historic District; and establishing an additional parking allowance for proximity to public parking areas.

1. **ZO 11-012** Consideration of a possible amendment to the Cottonwood Zoning Ordinance, Section 405 (Sign Code) establishing standards for electronic, LED, animated and other signs with intermittent illumination.
2. **ZO 11-013** Consideration of a possible amendment to the Cottonwood Zoning Ordinance, Section 405 (Sign Code) establishing new standards for political and campaign signs, including those located in public rights-of-way.
