

**SUMMARY REPORT**  
**OF COUNCIL ACTION TAKEN AT THE SEPTEMBER 7, 2010, SPECIAL MEETING HELD AT 5:30 P.M. AT THE CITY COUNCIL CHAMBERS BUILDING, 826 NORTH MAIN STREET, COTTONWOOD, ARIZONA.**

This summary is a statement of legal actions taken by the Cottonwood City Council at a regular meeting pursuant to A.R.S. § 38-431.02(D.), and is being provided as required by A.R.S. § 38-431.01(D.).

**Council Members Present:** Mayor Diane Joens, Vice Mayor Karen Pfeifer, Council Members Tim Elinski, Duane Kirby, Linda Norman, Terence Pratt, and Darold Smith.

Mayor Joens called the meeting to order at 5:30 p.m.

ITEMS FOR DISCUSSION, CONSIDERATION, AND POSSIBLE LEGAL ACTION:

RESOLUTION NUMBER 2536—APPOINTING AN ADMINISTRATIVE HEARING OFFICER FOR THE CITY OF COTTONWOOD

The Council unanimously approved Resolution Number 2536, which appoints Linda A. Hobson as the Administrative Hearing Officer for the city. Duties of the Hearing Officer include review of civil code violations and complaints generally filed by city staff in response to perceived code violations.

RESOLUTION NUMBER 2537—APPOINTING A MEMBER OF THE INDUSTRIAL DEVELOPMENT AUTHORITY BOARD FOR THE CITY OF COTTONWOOD

The Council unanimously approved Resolution Number 2537, which appoints Michael Warren as a member of the city's Industrial Development Authority Board for a four-year term. The Industrial Development Authority's purpose is to assist businesses to expand manufacturing, industrial, and commercial enterprises within the City of Cottonwood. It is a means for qualifying applicants to locate or improve qualified projects in the city through the use of industrial development bonds.

RESOLUTION NUMBER 2538—APPOINTING A MEMBER OF THE INDUSTRIAL DEVELOPMENT AUTHORITY BOARD FOR THE CITY OF COTTONWOOD

The Council unanimously approved Resolution Number 2538, which appoints Pat Bonomo as a member of the city's Industrial Development Authority Board for a two-year term.

ADMINISTRATION OF THE OATH OF OFFICE TO THE APPOINTED HEARING OFFICER AND MEMBERS OF THE INDUSTRIAL DEVELOPMENT AUTHORITY

The City Clerk administered the Oath of Office to Linda Hobson, Michael Warren, and Pat Bonomo.
