The **Draft *Cottonwood General Plan 2025*** is being circulated to agencies, organizations and the public for review and comments. Public Open House meetings will be held in February and March. Public Hearings will be scheduled for April and May. Comments, questions and input are welcome.

The ***Cottonwood General Plan 2025*** is a statement of goals and related policies to help guide the physical, economic, and environmental growth and revitalization of the city. It acts as a blueprint for future growth and development.

**Review Process:** The ***Cottonwood General Plan 2025*** update process began in October 2012 with a series of well-attended visioning workshops. Through the first half of 2013, the **General Plan Steering Committee** met twice a month to review the draft plan sections and provide recommendations. Information was posted to the City website to allow for additional public review and comments.

**Cottonwood General Plan sections include the following:**

Vision and Guiding Principles, Land Use, Circulation, Growth Areas, Open Space and Parks, Water Resources, Environmental Planning, Cost of Development, Housing, and Historic Preservation .

**PUBLIC REVIEW SCHEDULE**

- **Fall 2013:** The Preliminary Draft Plan was circulated for review and comments.
- **February 20 & March 26, 2014:** Open House Presentations - Cottonwood Recreation Center.
- **April 21, 2014:** The Planning and Zoning Commission holds Public Hearing on the General Plan.
- **May 6, 2014:** The City Council holds Public Hearing on the General Plan.
- **November 4, 2014:** The updated ***General Plan 2025*** will be placed on the ballot for the public vote.
