You must provide the City of Cottonwood with a certificate of insurance listing the City of Cottonwood as additionally insured for \$1,000,000 and describe your activities at this event. (except vendors that just showing)

INDEMNIFICATION OF CITY AGAINST LIABILITY

Vendor agrees to indemnify, defend, save and hold harmless the City of Cottonwood, Event Sponsors, and Thunder Valley Rally and any jurisdiction or agency issuing permits for any work included in the event, and their respective departments, directors, officers, officials, agents, employees, volunteers and contractor (hereinafter referred to as Indemnitee) from and against any and all claims, demands, actions, liabilities, damages, losses or expenses, including court costs, attorney's fees, and costs of claim processing, investigation and litigation (hereinafter collectively referred to as "Claims") for personal and bodily injury (including death) or property damage caused, or alleged to be caused, in whole or in part, by the negligent or willful acts or omissions of Sponsor or any of Sponsor's directors, officers, agents, volunteers, employees or contractors. This indemnity includes any claim or amount arising or recovered under Workers' Compensation Law or arising out of the failure of the Vendor to conform to any federal, state or local law, statute, ordinance, rule, regulation or court decree. It is the specific intention of the parties that the Indemnitee shall, in all instances, except for claims arising solely from the negligent or willful acts or omissions of the Indemnitee, be indemnified by Vendor from and against any and all Claims to the fullest extent of the law. It is agreed that Vendor will be responsible for primary loss investigation, defense and judgment costs where this indemnification is applicable.
