Pursuant to Arizona Revised Statutes Section 34-201, notice is hereby given that the City of Cottonwood ("City") will accept bids with the intention of entering into a contract for 10th Street Improvements in Cottonwood, AZ (the "Project"). This project consists of the reconstruction and modernization of 10th Street between Mingus Avenue and Main Street to include new curb, gutter, sidewalk, bike lanes and new pavement section. This project is funded by a federal Community Development Block Grant from the Arizona Department of Housing.

Bids shall be enclosed in a sealed envelope clearly identified as **10th STREET IMPROVEMENTS**. The name and address of the entity submitting the bid shall also be clearly marked on the sealed envelope. It is the sole responsibility of the entity submitting the bid to see that their bid is received at the proper time. The bid shall be submitted to the **City of Cottonwood Purchasing Division located at 199 S 6th Street, Cottonwood, AZ 86326 by 2:00 PM on Friday, July 19, 2013**, at which time all bids shall be opened and the name of each Bidder and the amount of its bid shall be publicly read. **Late bids will not be considered and will be returned unopened.**

Solicitation documents are available by email by contacting the Purchasing Division at (928) 340-2714, or via the Public Purchase website at www.publicpurchase.com.

A pre-bid meeting will be held on Wednesday, July 10, 2013, at 1:00 p.m. in the Verde room at the Cottonwood Recreation Center located at 150 S 6th Street, Cottonwood, Arizona, 86326. Although this meeting is not mandatory, it is highly recommended that all interested firms attend.

Each bid shall be accompanied by a certified check, cashier's check or surety bond for ten percent (10%) of the amount of the bid as a guarantee that if selected, the Bidder will enter into a contract to construct the Project in accordance with the plans and specifications. Any surety bond submitted in compliance with this requirement shall be executed by a surety company or companies holding a certificate of authority to transact surety business in Arizona issued by the director of the Department of Insurance pursuant to Arizona Revised Statutes Title 20, Chapter 2, Article 1; shall follow the form prescribed in Arizona Revised Statutes Section 34-201; and all liabilities on the bond shall be determined in accordance with that section as if it were copied at length therein.

The City of Cottonwood will select a Bidder based on the lowest responsible and responsive bid. In accordance with Arizona Revised Statutes Section 34-201(A)(4), the City reserves the right to reject any or all bids or to withhold the award for any reason the City determines.
